Notice is hereby given that the Bellingham City Council will hold a public hearing on **November 9, 2020 at 7:00 PM**, or as soon thereafter as possible during their Regular City Council meeting, which will take place remotely, to take public comment on the following:

To consider an amendment to the York neighborhood plan proposed by the York Neighborhood Association. The proposed revisions are intended to clarify the current language for Area 1, encouraging the City to possibly acquire the industrial land along Whatcom Creek and/or obtain easements as redevelopment occurs. The proposal also provides some guidance for future opportunities for multi-family zoning along the northern side Meador Avenue.
