Thanks for your call this morning. I hope it was clear that my interest is in having the best, and most comprehensive plan we can have to serve us over the next 30 years or so. Dear Fairhaven Stakeholders:

This is an update on the ongoing Fairhaven Neighborhood and Urban Village planning effort. Following the release of the draft documents on December 21st, the City has received positive and constructive comments, and has heard some concern about the process, one of which being that the timing of the release and finalization of the drafts and various advisory board meeting schedules may not allow adequate time for busy commercial business owners to fully participate. Therefore, the City has adjusted the schedule to allow all stakeholders additional time to read the draft documents, respond with comments, and attend the public meetings should they choose to do so.

The advisory board meetings provide the opportunity for staff to gain additional input on specific aspects of the draft documents. Be aware that these are public *meetings* -- not public *hearings*. The revised schedule is as follows:

- Historic Preservation Commission: Introduction of Design Standards and regulations - Tuesday, January 10, 2012, 4:00 p.m., Council Chambers
- Mayor's Neighborhood Advisory Commission: Overview of plan and regulations, Wednesday, January 18, 2012, 6:30 p.m., Mayor's Board Room

- Historic Preservation Commission: Feedback meeting on Design Standards and regulations, Tuesday, January 24, 2012, 7:00 p.m., City Council Chambers
- Transportation Commission: Transportation and Parking Chapters and parking regulations, Tuesday, February 7, 2012, 6-8 p.m., Mayor's Board Room

During the month of January and first half of February, staff will continue to review public comments and advisory board input, and prepare the final draft documents for the public legislative review process. The new deadline for a complete final draft is **February 14, 2012**, 30 days in advance of Planning Commission public hearing which is now scheduled for **March 15, 2012**.
