I, Adam Doupé, declare:

- 1. I am over the age of eighteen, not a party to the above-captioned matter, and am competent to testify to matters herein.
- 2. I am an attorney with the law firm of Buchalter, P.C., counsel of record for Intervenor, 52^{nd} & Brooklyn, LLC.
- 3. Attached hereto as Exhibit "A" and incorporated by reference herein is a true and correct copy of video footage taken during the day of an encampment of unhoused persons

to the east of Intervenor's real property. The video footage was taken in January 2024 using a drone flown by a licensed commercial drone videographer company, DPdrones.

- 4. Attached hereto as Exhibit "B" and incorporated by reference herein is a true and correct copy of drone video footage taken of the same real property in January 2024. In this second video clip, the drone's camera utilizes heat seeking technology to detect people and objects emitting heat.
- 5. The local news media has widely reported regarding an encampment of unhoused persons located on real property immediately adjacent to Intervenor's property. On August 2, 2024, I accessed a news article from the Bellingham Herald's website reporting on this issue. - 6. On May 23, 2024, I submitted a separate declaration in support of Intervenor's Motion to Intervene. Attached to my previous declaration, and incorporated by reference herein, is a true and correct copy of a letter that I sent to Defendant Li-Ching Fang and other owners of adjacent properties. The letter was attached as Exhibit "D."
