A new residential multi-family project, known as CityView, consisting of 106 units on a vacant 11-acre parcel generally north of Consolidation Avenue between Puget and Nevada Streets in the Puget Neighborhood.

The Planning Commission's role is to review the written record, which includes the applications, all materials submitted to support the applications and public comments received in response to the application materials, as well as those provided at the public meeting.

Based on these matters of record, the Planning Commission shall make a recommendation to the Planning Director identifying what substantial planning issues or matters of public interest (if any) associated with the proposal should be considered and closely reviewed during the environmental and land use permit review of the proposal. The Planning Commission will not be recommending approval or denial of this application.
