Phase One Park Improvements include:

Age separated playground/diggable area/spin zone/games/Twister game/	Park signage, interpretation signage, and wayfinding	Critical area buffer mitigation: signage, , fence, planting, weeding, mulching
Pedestrian amenities: benches, picnic tables, trash cans, bike racks, recycling receptacles, etc.	30'x60' reservable picnic shelter with sink, water, electrical supply, and park grill – Similar to Squalicum Creek Park	Walkways, trail loops and trail connections to points outside the park. 5 wetland crossings.
