ANNUAL STREET OBSTRUCTION BOND**

KNOW ALL MEN BY THESE PRESENTS:

That the undersigned, _____, as *Principal* and _____, a Corporation of the State of Washington, authorized to do business as *Surety*, are held and firmly bound unto the **CITY OF BELLINGHAM**, a Municipal Corporation, in the full and just sum of _____ (\$_____) for payment of which, well and truly to be made, we bind ourselves, our heirs and assigns, jointly and severally, firmly by these presents.

THE CONDITION OF THIS OBLIGATION IS SUCH THAT,

WHEREAS, the above bounden *Principal*, during the balance of the calendar year _____ expects, on various occasions, to make application to the **CITY OF BELLINGHAM** and receive permits from said authority for the repair, replacement and/or obstruction of streets and sidewalks in the city of Bellingham, and

WHEREAS, the granting of said permits during the said part of said calendar year is conditioned upon the filing of this bond in the sum of FIVE THOUSAND AND NO/100 DOLLARS (\$5,000.00),

NOW, THEREFORE, if the above bounden *Principal* shall carry out all work within City rights-of-way in accordance with the provisions of Chapter 13.12 of the Bellingham Municipal Code and all other applicable laws and ordinances, and shall restore all such work sites to their condition prevailing before the commencement of work, and shall guarantee all such work and restoration for a period of at least one year following completion and approval against defects in labor and materials supplied, to the extent of twenty-five percent (25%) of the principal amount of this bond ONE THOUSAND TWO HUNDRED FIFTY AND NO/100 DOLLARS (\$1,250.00), then this obligation shall become null and void; otherwise it shall remain in full force and effect until _____, 20____, and the guarantee period provided hereby unless renewed by Continuation Certificate.

This obligation may be cancelled by said *Surety* by giving thirty (30) days notice in writing of its intention to do so to said Obligee; and the said *Surety* shall be relieved of any further liability under this bond thirty (30) days after receipt of said notice by said Obligee.
