**DECLARATION:**

  1. The City accepts the 10% petition to annex to the City of Bellingham for further evaluation in accordance with City and State law with the proposed annexation boundary as shown on Exhibit A, attached hereto;
  2. City staff is directed to provide additional information regarding the proposed annexation, including an evaluation of service impacts of the proposed annexation; and
  3. If the annexation is approved, the City will require simultaneous adoption of the comprehensive plan and zoning and development regulations consistent with Bellingham’s Comprehensive Plan and require the annexed area to assume all of the City’s indebtedness.
