Hi Morgan.

As we discussed during our phone call yesterday, the city conditionally accepts your request to extend the date by which you must submit a full response to the issued July 6, 2020 request for information (July 6 RFI) by an additional 150 days. This extension comes with the condition that you in return agree to give the city 28 days, which is an additional 14 days pursuant to BMC 21.10.080, to determine whether your response satisfies the July 6 RFI.

The 150-day extension establishes April 2, 2021 as the new date for submitting the information to prevent the applications for the CityView development from becoming null and void under the same terms identified in the July 6 RFI.

Please verify by responding to this email that you accept the terms of this extension.

This email should be kept in your records as the city's official determination approving the time extension.
