



Qualifying Fixtures or Equipment and Recycling Instructions

Qualifying fixture retrofits

Rebates are available for qualifying efficient fixtures/products that are replacing high-use fixtures/products. The rebate amount is based on the pre-tax price of the qualifying fixture/product, up to the specified amount below- whichever is less. Rebates cover the cost of the fixture/product only, not additional parts, labor/delivery charges, or tax. Pre-approval is required for all rebate projects. Approval is assessed on a first-come, first-served basis and contingent on funding. Some restrictions apply.

WaterSense Labeled Fixtures/Products

- **Toilets** - two rebate types available:
 - Up to \$100 rebate for replacing 3.0 gallons per flush (gpf) or greater toilet models (those produced/installed before 1994) with high-efficiency 1.28 gpf or less toilets.
 - Up to \$100 rebate for replacing 1.6 gpf or greater toilets with 0.8 gpf toilets. Toilets must be used by at least 5 building occupants and operate at least 40 hours per week.
- **Urinals** - up to \$100 per urinal installed
- **Pre-rinse spray valves** - up to \$25 per spray valve installed
- **Landscape irrigation controllers** - up to \$700 for installation of weather-based irrigation controllers

ENERGY STAR® Certified Appliances

- **Clothes washers:**
 - Up to \$100 for a qualifying high-efficiency clothes washer
 - \$300 or up to 50% rebate for coin-operated clothes washer
- **Commercial kitchen equipment** - \$300-\$1,500

Recycling Information

Both Sanitary Service Company (SSC) and Recycling and Disposal Services (RDS) offer toilet recycling. Costs are minimal and project participants are required to recycle toilets. The crushed porcelain can be used in sidewalk and roadway construction projects within the City- see one of the first projects at:

Sanitary Service Company Inc.

For individual toilets, SSC accepts toilets (or sinks) for recycling at \$5 each at the company's Roeder yard. SSC also sets up jobsite containers for larger projects, etc. but requires previous notice to schedule a drop box.

An example of what to expect:

- The container would be a 10- to 30-yard drop box (with a mesh lid and barn doors at one end).
- Participant would carry toilets to the drop box and with all non-porcelain parts removed (gaskets, seats, hardware, etc). Toilets MUST have all parts removed.
- SSC then hauls the container away to either RDS or Cowden to be crushed and recycled as aggregate in new concrete. Previous costs for projects were: \$35-\$45 container rent (per month); \$90 haul fee; and an estimated \$15-\$20 per ton for the tipping fee (to dump the toilets with waste concrete). Mileage >5 mi. one way is \$2.00/mile.
- Toilets are estimated to weigh about 50 lbs each. At 50 toilets, the recycling should cost under \$200, which is less than dumping with garbage.

Recycling & Disposal Services (RDS)

RDS accepts toilets for recycling at \$3 per toilet. The toilets should have all non-porcelain parts removed (gaskets, seats, hardware, etc). Cowden picks up porcelain toilets and waste concrete from RDS to crush and recycle as aggregate in new concrete.
